Child Foundation helps children in need, who have been identified as high achievers, to remain in school. We believe education can move a child beyond the stigma of poverty and give that child the tools to reach his or her true potential. Since our inception in 1994, Child Foundation has provided basic necessities to children living in hardship enhancing the quality of the life for these children as well as their respective families. By providing education, Child Foundation hopes to eliminate children prematurely leaving school, and, in certain countries, early matrimony.

Child Foundation has sponsorship programs in Afghanistan, Indonesia, Iran and the United States. Over 4,000 families and children are served by Child Foundation's individual sponsorship programs. Approximately 25% of these children are enrolled or have graduated from university or college programs. Child Foundation's sponsorship programs in Afghanistan and Indonesia continue to grow. This year an office was established in the city of Mazar Sharif, Afghanistan. There are currently 4 different programs for children with special needs. These are programs for who have been abused, children who are visually impaired, deaf children, and children with medical needs such as cancer.
